#### Singing

The changes to restrictions include the following:

Singing carries a high risk due to increased droplet spread. When singing, congregation/attendees should maintain a minimum of two metres from each other and cleaning of areas or equipment in range of singers/ performers should be increased.

We contacted the ACT Govt hotline, and they provided clarifying advice about this statement. The Elders have now decided that congregational singing will be allowed at the Christmas Celebration services on both Sunday 20 December and Christmas Day 25 December.

To minimise the risks associated with singing (increased droplet spread), the advice emphasised the requirement to always maintain social distancing between individuals and groups (apart from family/household groups) and that people should face the same direction when singing.

People may also choose to wear a mask as extra protection.

### **COVID Update - Current restrictions**

Each time restrictions are changed they are published in the App under About Us/COVID Safety Plans.

Restrictions have been eased changing the capacity of spaces from 4 sq mtrs to 2 sq mtrs both inside and outside of Places of Worship provided that we use the CBRapp to record attendees' details.

For churches with very large auditoriums/sanctuaries, this makes significant changes to the number of people who can be accommodated. However, because the 1.5 mtr distancing rule is still in force, this makes very little difference to the numbers we can have in our Auditorium for Sunday services. Any extra seats that can be correctly distanced do not provide good visibility.

We have registered for the App and we will be displaying the QR Code from ACT Health at our Christmas Services. This means that people who have downloaded the App to their phones may choose to record their attendances using their phones

The Visitor Book sheets will continue to be provided for people not using the CBR App.

#### CBR Check In App set up

The following is the experience of one of our members trying to use the CBR Check In Ap



I was trying to use the booking system associated with the Check In CBR app.

I was under the impression (because of similar systems used by MacDonalds, Hungry Jacks, etc) that I didn't need to use anything but my camera on my phone to scan the QR Code, and that would take me to the appropriate web page to register my attendance.

I have now learnt that individuals DO NEED TO DOWNLOAD the Check In CBR app onto their phones before they can use the QR Code which has been supplied for any establishment using that app. So for those who would want to use the Check In CBR option (instead of signing in with a pen upon arrival), they would need to download the app onto their phone.

It is straightforward to do this (and provides access to a whole lot of businesses using it). I downloaded the app, put in my name and contact phone number (or email, or both if people wish), and give the app permission to use my camera. And it is set to go for church or any business using that app. If I want to register any guests I have with me, I can do that easily with that app.

#### Manage 1.5 mtr distancing

The Transition and COVID Safety teams have taped the floor of the Auditorium and place chairs at the correct distance and have carefully worked out how ushers are to group chairs for couples and family groups to ensure you are safe and compliant.

#### But what about after the service when people leave their chairs?

The legislation states that it is the responsibility of the individual to maintain safe distancing. An easy way to get the distance right is that there needs to be two of the carpet tiles on the floor between you and the next person. If this is not possible, then a mask may help to keep you safe.

The COVID Safety team wear masks as they often need to be less than 1.5 mtrs from you. **Finance**

## Jenke Cct land – status report

The disposal of the land at Jenke Cct and application of proceeds to the loan on Garratt Street has been progressing in the background of this year's events. Mona Young, our treasurer was delegated to progress this project after the purchase of Garratt Street was finalised.

It's important to realise that disposal of the land is much more complex than selling a block of unencumbered residential land.

#### Preparing for sale

Her first task, completed in December 2019, was to have the land cleared of the storage containers and then to set about researching all of the steps to be taken and to proceed to deal with each item of the list so that the land was ready for sale.

The land was granted under a Crown Lease which, it is generally believe, was concessional. Confirmation of the concessional status needs to be confirmed.

#### Assembling required legal documentation

The lease was conditional, and Mona has obtained a number of documents to show that these conditions have been met as they were not in our church or, in some instances, the government's records as the acquisition of the land pre-dates both digitised/electronic records and the establishment of the ACT government.



#### Transfer of the lease to potential buyers

Mona obtained advice from the government that transfer of the leases would be considered if the purchaser can meet the same requirements for the grant of the lease as our church for example proof of registration as a not-forprofit entity, articles of association and other similar supporting evidence and evidence that they can/will use the premises in accordance with the crown lease conditions.

#### Defining potential buyers

Here are a couple of the clauses from the Crown Lease that set limits on who we might sell to:

Clause 3 (d) The lessee covenants to use the premises **only for the purposes of a church** and subsidiary thereto related church activities

Clause 3 (I) The lessee will not assign transfer or part with possession of the whole or any portion of the premises without the **previous consent in writing** of the Commonwealth (now the ACT Government).

#### The Trustees and transfer of the Crown Lease to Tuggeranong Baptist Church Incorporated

The lease was granted before the church became an incorporated body so has been held in trust for us by *The Association of Baptist Churches of the Australian Capital Territory Incorporated*.

This means that any sale would have included processes required by the trust and this would add to the complexity of the sale and time taken to complete same.

In the meanwhile, the Association is in the process of being wound up and will be transferring ownership to us. They will be meeting the legal costs of the transfer and will, as part of the process secure for us confirmation of the concessional status of the lease.

#### Discussions with potential buyers

Once the lease is in our own name and its status confirmed and now that we have all of the documentation required, we will be able to have reasonable conversations with organisations that have made tentative enquiries about the availability of the land.

#### Members vote

Any proposal to sell the land requires that a special meeting and a two-thirds majority of the Members in the affirmative before a proposal shall be deemed to have been agreed by the Membership. (TBC Constitution).

We will follow the procedure when a firm offer is received.
